Photography at the University of Southern California Bylaws: Table of Contents

Article I: Framework and Eligibility

I.1 This document is the Bylaws of Photography at USC. This document is distinct from the Photography at USC Constitution and the rules set forth in the Constitution shall take precedent over the Bylaws.

Article II: Policies

II.1 Attendance shall be measured at certain Photography at USC events in order to determine acceptance to other, distinct events.

II.1.A A set amount of points shall be issued to every member who attends the majority of Photography at USC events, those including but not limited to:

II.1.A.i Workshops, socials, banquets, photo walks, critiques, showcases, and shows.

II.1.A.ii Parties and retreats will not count toward point totals.

II.1.B In determining acceptance for popular events, including but not limited to retreats, the member who has the greatest number of total points and signed up for the event shall be chosen first, and so on and so forth.

II.1.C These points shall reset every semester to zero (0).

II.1.D Non-members cannot accrue points.

II.1.E Members may receive one (1) point for every semester they are active in Photography at USC. These points accumulate and cannot be reset.

II.2 Members may be removed from Photography at USC at the discretion of the E-Board

II.2.A Three-fourths, or seventy-five percent, of the E-Board must approve the removal of a member at an E-Board meeting.

II.2.B Members may not be removed without rightful cause, in accordance with the Constitution or these Bylaws, Article VI.

II.2.C If removed from Photography at USC, members must be alerted in appropriate fashion and time.

II.2.D Members may be "blacklisted" from Photography at USC events with rightful cause in accordance with the Constitution or these Bylaws, Article VI.

II.2.D.i If blacklisted, members may not attend off-campus events.

II.2.E E-Board has the right of refusal for any attendee for any event.

Photography at USC events shall:

II.3

II.3.A Be paid for by all members unless they meet specific requirements set by the E-Board.

II.3.A.i If a member proves their inability to afford to pay for an event, Photography at USC must assist in payment. II.3.B Refunds for events shall be issued to members in accordance with the refund policy laid out in communications. If no refund policy is expressed, then refunds shall be issued at any time before the event.

II.3.C All members attending events where E-Board determines a waiver is necessary must sign the waiver before the event or they may not attend the specific event.

Article III: E-Board

III.1 E-Board Members may be impeached from Photography at USC with rightful cause in accordance with the Constitution or these Bylaws, Article VI.

III.1.A E-Board Members may be impeached by a two-thirds vote of the remaining E-Board Members at an E-Board meeting.

III.1.B The motion for impeachment must be brought up by one E-Board Member and seconded by another, distinct Member.

III.1.C If impeached, the E-Board Member is removed from the E-Board, but shall remain a member of Photography at USC.

III.1.D There is then a one-week grace period, and at the next E-Board meeting, the remaining E-Board members must follow the line of succession laid in out in the Constitution.

III.1.E At this same E-Board meeting, the E-Board must decide whether or not the impeached E-Board Member may be allowed to be a member of Photography at USC, following the policies laid out in these Bylaws.

Article IV: Media Release

IV.1 In paying the member fee and attending an event, members grant permission to Photography at USC to use their "media," or image, in any publications, including but not limited to:

IV.1.A Videos, pictures, email blasts, recruiting brochures, newsletters, magazines, website, and general publication.

IV.2 Members hereby waive any right to inspect or approve the finished photographs or electronic matter that may be used in conjunction with them now or in the future, whether that use is known to them or unknown, and they waive any right to royalties or other compensation arising from or related to the use of the image.

IV.3 Whenever possible, Photography at USC will give appropriate credit to members' when using their "media."

Article V: Standing Rules

V.1 The Photography at USC logo shall remain unchanged unless a proposal to change the logo receives a two-thirds vote by the E-Board.

V.1.A A vote in favor of changing the logo creates a new Logo Exploratory Committee made up of the President, Vice President, and Marketing Branch.

V.1.A.i The Logo Exploratory Committee shall present to the E-Board a proposal for the new Photography at USC logo. If the E-Board votes in favor by a majority, it passes and becomes confirmed as the new logo.
V.1.A.ii The existing Photography at USC logo shall remain intact until the E-Board make the vote. If the new logo does not pass, the existing logo stays in place.
V.1.A.iii If a proposed new logo fails to pass the E-Board, the Logo Exploratory Committee can re-present to the Senate until a new logo passes.

Article VI: Unethical Misconduct and Responsibility to Report

VI.1 Definitions

VI.1.A An E-Board Member: Any person appointed to serve in Photography at USC E-Board, or any other person affiliated with Photography at USC in such a way as to have official or unofficial duties as part of the normal and ordinary course of business, as defined by the Photography at USC Constitution, Bylaws, or any other official Photography at USC document.

VI.2 Misconduct

VI.2.A Any of these actions of misconduct are grounds for investigation and potential removal or impeachment of a member or E-Board Member. VI.2.B Conflict of Interest

VI.3 Procedures

VI.3.A In the event that any member believes that he/she has evidence of blatant misconduct or has witnessed the misconduct of a member, acting in the best interest of Photography at USC has the responsibility to take the necessary actions against those violations.

VI.3.B Any member who feels that another member has committed any enumerated or expressed misconduct against the regulations of the Photography at USC Constitution and Bylaws and has caused injury to any student, the club, or the University shall file a complaint with the E-Board.

Article VII: Amendments

VII.1 If a proposal to amend these Bylaws receives the votes of two-thirds of the current E-Board, the Bylaws shall be declared duly amended.

VII.2 Bylaw amendments shall take effect at the next E-Board meeting.VII.3 If a change to the Bylaws is deemed necessary to the function ofPhotography at USC immediately, by a unanimous decision of the Executive Branch, and a vote by the E-Board, the Bylaws shall be declared duly amended.

Article VIII: Enactment

VIII.1 These Bylaws shall be in full force and effect following a positive vote by two-thirds of the E-Board. In all cases of discrepancy regarding policy, procedure, rulings or any other Photography at USC business, the Constitution shall take precedence.
